# **EXECUTIVE BOARD MEETING**

Saturday, November 6, 2010

The meeting of the Executive Board was officially called to order at 8:40am. In attendance were: Local President Hogrogian, Vice President Blum, Local Treasurer Tabarus, Recording Secretary Yancey, and State Representatives, Tom Ruther, Charles Price, Andrew Piacente.

The minutes from the last Executive Board meeting held on July 29, 2010 were officially read into the record by the Recording Secretary. Hearing no additions or corrections the following motion was made:

The review of the financial report commenced at 8:00am. Board members discussed the expenditures for the fiscal period of July1, 2010 thru October 31, 2010. After full review and a question and answer period, the following motion was made:

### TREASURER (TABARUS)

Tabarus provided a detailed financial report and discussed Local 300 business practices for the fiscal period. The report included updates on arbitration expenses, pension funds, interest from CD accounts, this years LM-2 report, and the IRS 990 and 990T. The LT went on to discuss the current MHBP enrollment numbers; and discussed Membership dues both Regular and Associate as reported from the dues check off. Continuing on, Tabarus discussed the spending practices in association with office supplies, office equipment and other various materials related with running an organization of this nature.

In addition to his general duties as Treasurer, Tabarus also assists and consults with the Branch Presidents and Stewards regarding grievances and is responsible for the Local's webpage and the Local 300 Newsletter. Tabarus is also tasked with tracking new member sign-ups; and processing the mutual agreements regarding transfers from other crafts to the MHU. The LT also attends the various Branch meetings serves as Arbitration Advocate on behalf of the Local when needed.

In conclusion of the report, Local 300 will continue with conservative spending practices and will continue to provide effective union representation to our members. Ending the Treasurer's report following motion was made:

## **LOCAL PRESIDENT (HOGROGIAN)**

The overall view of the Compressions and Elimination plans have been the worst seen in the history of this postal organization. With at least three facilities closing in the past few months (Bronx, HASP, Carteret, and West Jersey) in his comprehensive report, updating the USPS Tour Compression/Elimination and Consolidation initiative, President Hogrogian stated that the Postal Service is determined, to put forth more changes including <u>"right-sizing"</u> which means a possible restructure of job assignments and reduced overtime.

The LP also discussed the Postal Services pilot program of privatizing the BMC Bed loads. Continuing the report Hogrogian gave an update on AMP studies, future excessing and Function 4 reviews; with Morgan currently under assessment. The LP also discussed Postal Management's increased efforts in the National Reassessment Program; now in Phase 2. The Program targets Limited duty employees. Recently, Local 300 formed a NRP Task Force to assist in this area. An <u>NRP Guideline Manual has been developed by the Task Force and distributed to the Branches</u>.

In discussion of other Union Business, the President's report continued with a detailed summation of the Local 300 Elections of Officers, the LIUNA Convention and the selection of the Judges of Elections. After full consideration based upon the information provided by the LP, the Board motioned the following:

Motion by Blum, 2<sup>nd</sup> by Price: The Local 300 Executive Board will pay up to 4-days lost time ("<u>actual</u> <u>attendance</u>") to the delegates attending the LIUNA Convention.

#### **VICE PRESIDENT (BLUM)**

In his detailed report Vice President Blum discussed a variety of topics concerning the Local starting with the meeting of R.I. 399 Dispute Resolution Committee. The Committee has met three times and discussed the cases of Mid Hudson, at which the Committee has signed off on the case of Custodians doing Mail Handler work. The results in the case of the Bulk Mail-NJ (NDC): Clerks spreading mail behind SPBS operation; was remanded back to the Local parties.

Concerning the <u>NY Metro RI-399</u>: The cases of: Brooklyn - Low Cost Tray Sorter and CT -spreading mail in shared operation were appealed.

In addition to his general duties as Vice President, Blum also assists and consults with the Branch Presidents and Stewards regarding grievances; serves as Political & Legislative Coordinator for Local 300; and servers as PAC Coordinator. The VP discussed any pending legislation and Blum has developed and distributed "A call to action" message to the membership regarding PAC donations. Rounding off his other duties Blum also serves as MHBP Representative for the Local and is the Coordinator of member premiums and office equipment. The VP also attends various Branch Meetings, Stations visits and serves as Arbitration Advocate and Technical advisor when needed.

## **RECORDING SECRETARY (YANCEY)**

It is the responsibility of the Recording Secretary to receive all trial board charges, document and distribute the proper response to all parties concerned. The Local is pleased to report that there are no trial boards pending at this time.

Recording Secretary Yancey included and discussed in the report the ongoing efforts of the Women's Caucus to create additional resources that help our members cope with the Postal Services restructure plans. Continuing along this line of discussion, the RS discussed the "Letter of Encouragement and Appreciation" presented to Branch Presidents during the Local Union Council meeting. The RS feels that because of the Postal Services aggressive plans to restructure, a new approach in addressing today's issues is necessary. The more assistance and resources that are developed and provided to our members through this Local will benefit the membership in the long haul.

#### **NEW YORK (PIACENTE)**

After the Recording Secretary's Report, NY State Representative Andy Piacente gave the NY State Report. The report included an update on Tour compression issues in Westchester and the impact the compression has had on the craft. Piacente discussed grievances that may have been filed as a result of Compression. In addition to his responsibilities as NYS Representative, Piacente also serves as Arbitration Advocate for the Local. Piacente has either arbitrated; served as technical advisor or has testified on behalf of the Local. Recently, Piacente testified at the Westchester P&DC Casual-in-lieu grievance. As a result Westchester prevailed in the case which reaped a large dollar amount for the Mail Handlers in the facility. In updating the Executive Board on the Port Washington excessing issue, the Local still awaits a conclusion from postal management.

#### **NEW JERSEY** (PRICE)

Price continues to address a variety of issues concerning the Local, specifically in the New Jersey District Price updated the Board on all RI-399 Inventory grievances previously filed and/or appealed to Step 3 and gave an update on the numerous grievances filed regarding violation of bid assignments or assignments not offered to the Mail Handler craft.

Price continues to address excessing issues around New Jersey and in the Associate Offices. Price has been successful in keeping the number of those being excessed down to a minimum. Price also discussed the aggressive upswing in disciplinary action in the Associate Offices. In addition to his responsibilities as NJ State Representative, Price also serves as Representative for the Local during the Open Season and the MHBP. As soon as results are in, Price will update the Board.

Tom has gained positive results for our members in this area, but cautions members to document their medical situation accordingly. Improper documentation result in delays.

In his other responsibilities Ruther serves as Arbitration Advocate for the Local, aggressively arguing cases in Stamford, Mid Hudson and Westchester; Ruther serves as Representative at the Regional Safety and Health Committee meetings; presenting the safety and health agenda on behalf of the Local and serves as Representative for the Local for the MHBP. Ruther gave an update on the Open Season.

Ruther ended with the report with an update on the Mets outing. The outing was deemed successful.
