EXECUTIVE BOARD MEETING

The meeting of the Executive Board was officially called to order at 9:07am.

In attendance were Local President Paul Hogrogian, Vice President Robert Blum, Local Treasurer Kevin Tabarus, Recording Secretary Linda Yancey and Local 300 State Representatives Andy Piacente, Charles Price and Tom Ruther.

After roll call, the minutes from the last Executive Board meeting held on <u>January 14, 2010</u> were officially read into the record by Recording Secretary Yancey. After the reading the following motion was made:

MOTION BY: BLUM, 2ND BY PRICE: TO ACCEPT THE MINUTES AS READ. MOTION PASSES: UNANIMOUS

FINANCIAL REVIEW

During the Financial Review which commenced at 7:00am, the Executive Board discussed the expenditures for the fiscal period of January 1, 2010 through April 30, 2010. After full review by Board members and discussion of the expenditures by the Local Treasurer the following motion was made:

MOTION BY: RUTHER, 2ND BY PIACENTE: TO GIVE SUBSEQUENT APPROVAL TO ALL LEGAL AND LAWFUL EXPENDITURES FOR THE PERIOD OF JANUARY 1, 2010 THROUGH APRIL 30, 2010.

MOTION PASSES: UNANIMOUS

TREASURER'S REPORT

In addition to the Financial Report, Treasurer Tabarus submitted a written Treasurer's Report that documented all relevant financial obligations, and offered updated information on changes in FDIC coverage, and Certificate of Deposit Registry Service Accounts. After entertaining questions from Board members, the LT suggested that it would be in the best interest of the Local if we reexamined the previous consideration of opening a CDARS. A discussion ensued on the matter and after full consideration the following motions were made:

In relations to the previous motion the following was made:

MOTION BY: TABARUS, 2ND BY PRICE: The Local 300 Executive Board grants approval to the Local Treasurer and the Local President to deposit funds in the following banks: Signature Bank, Dime Savings Bank of Williamsburg, Apple Bank for Savings, and Ridgewood Savings Bank.

MOTION PASSES: UNANIMOUS

Tabarus continued his report with a discussion on membership dues, (both associate and regular) which are in a declining situation at this time. Today, our regular membership stands at approximately 5,634 (down from last year) at a loss of approximately 300 members. Our number of associate members currently stands at 851, down from 1,085 (from the previous year). The Local Treasurer also discussed the new membership sign-up forms generated by the National Office. The Local Treasurer discussed enrollment in the MHBP within our Local area; and presented information on our reporting requirements with the DOL and the IRS. The yearend forms were explained (LM-2, IRS Forms 990 & 990T).

In conclusion of his report Tabarus discussed scholarship information, website updates and discussed our next newsletter. The following motion was made:

PRESIDENT'S REPORT

During his comprehensive report, LP Hogrogian discussed the USPS aggressive consolidation plans and the completion of the NYMA/NE merger. The merging of the NYMA with the North East area has resulted in combining many districts under one umbrella; causing a large shifting of mail between facilities. Further review finds that Function 4's, AMP Studies and excessing issues are rapidly moving through many facilities under Local 300 jurisdiction. Local 300 commits to investigating any infractions made by the Postal Service; including Casual-in-lieu justification. So far Local 300 has prevailed on many of the casual-in-lieu of cases filed. Further discussions included the Service's plans to progressively review the medical limitations of the Limited duty employees through the National Reassessment Program. To assist our members in this area, Local 300 has formed a NRP TASK FORCE. The Task Force will be chaired by President Hogrogian and include Local 300 Branch Presidents: Tom Mullahey of the NJ-NDC, Willie Delgado of Morgan P&DC and Stan Howard of ISC-JFK.

Continuing the President's report, Board members discussed the recent searches conducted by the Postal Service, as well as the Medical Units closed out of Postal facilities nationwide. Union representatives will alert our members to the searches; as well as requesting information from management; regarding the Standard Operating Procedure (SOP) of medical emergencies within the facilities. Hogrogian's report concluded with a review of the arbitration calendar, recent arbitration awards, a full litigation report and a discussion regarding next years Local 300 Elections and Conventions. A motion was made and resulted in the following:

VICE PRESIDENT'S REPORT

In his detailed report Vice President Blum discussed a variety of topics concerning the Local including; the schedule of the NY Metro R.I 399 Committee and the National Dispute Resolution Committee meetings. Some of the cases to be reviewed concern West Jersey, Mid Hudson and the Inventory Dispute for Greenwich CT.

The Vice President went on to discuss the Staten Island Letter Carriers Arbitration case which ruled that performance off spreading mail in the Stations falls under the jurisdiction of the Mail Handler craft. Blum also included in his report a discussion on the Inventories for the Associated Offices. Establishing these Inventories were put on hold as we are awaiting the outcome of several related cases that were presented at the National level of the grievance process.

Continuing the report Vice President Blum discussed our efforts at this years' planned Labor Day Parade with the NYCLC. Information will be disseminated when plans are made more specific. The VP also discussed and gave an updated report on our office equipment leasing options, and membership premiums. Further information on the equipment leasing will be disseminated to the Executive Board upon review of renewal options. The VP continued his report and led a discussion on contributing to the Political Action Committee. The VP submits that member contribution helps our political agenda regarding Mail Handler interests. We encourage our members to contribute to this effort.

RECORDING SECRETARY'S REPORT

In giving the Recording Secretary report, it is the responsibility of the RS to receive all trial board charges, document and distribute the proper response to all parties concerned. The Local is pleased to announce that there are no trial boards pending at this time.

Included in the report Yancey discussed her responsibilities as Chairperson of the Local 300 Women's Caucus. As always, in the Committee's efforts to fully address the many inquiries of our members and stewards'; since the last Executive Board meeting Caucus members attended the CUNY Women's Conference in NYC. The Conference brought together women leaders from many unions, and other community based organizations. The Conference discussed ways to increase the presence of women in leadership positions, and grassroots organization. The lessons learned from the workshops and discussion groups will lead to developing more informational resources for our members.

In finalizing the report Yancey gave an update on the distribution of the commemorative for Women's History Month, (which was a pen) that connected to the History Month theme of "Writing Women back into History"; and lead a discussion on this year's Family Day Event.

Most recently, Piacente testified at the Westchester P&DC Casual-in-lieu grievance. We are awaiting the results. The Local expects a positive outcome.

Price also continues to address the upswing in disciplinary action in the Associated Offices. In addition to his responsibilities as NYS Representative, Price is also one of the representatives working on behalf of the Local for the Mail Handler Benefit Plan. Price continues to disseminate updated information upon formulation.

Tom also discussed his affiliation as representative for the Regional Joint Labor/Management Safety and Health Committee. The Committee has been combined into 1 unit and now meets in Windsor CT. Any safety concerns or agenda items please contact Tom at Local 300 Headquarters.
