# TREASURER'S REPORT (TABARUS)

Local Treasurer Tabarus submitted a written report detailing the Local's financial obligation. The LT discussed our current membership dues (associated and regular); and how they relate to our financial stability. Regular membership dues have decreased slightly. Included in his report Tabarus discussed the various Scholarship programs that are available to our members. Further information will be available on the Local's

website. Brother Tabarus concluded his report with a discussion on the Local 300 newsletter. Those wishing to submit articles of interest may do so by June 11, 2009.

## PRESIDENT'S REPORT (HOGROGIAN)

As always the LP gave a comprehensive report on the state of the Local and issues confronting the Union. Brother Hogrogian discussed and entertained questions and comments on a variety of topics including: issues related to mail volume decline, and the possible impact on mail handler operations; arbitration schedules, recent training sessions and seminars, recent changes in regulations by the DOL regarding FMLA, the Postal Service's Tour/Elimination/Compression plans, and our immediate involvement in responding to these changes. AMP studies, facility closings, as in the case of Newark AMC, which will close its doors on June 6, 2009. Deployment of new automation such as the FSS; active litigation, and the Bulk Mail Centers, and their proposed conversion to the new Network Distribution Centers (NDCs). The LP also discussed management's scaling back of the Ergonomics and the Voluntary Protection Programs; which may be due to the postal service's financial misfortunes. In closing the LP discussed the Legislative Conference held from May 20th to May 21st. in Washington, DC. MHU Representatives from around the country met with Congressional leaders to discuss issues affecting the Mail Handler craft, such as, H.R. 22 - Change the prefunding of retiree health benefits, FERS Sick Leave Crediting for Retirement (H.R. 1256), and the Employee Free Choice Act (S. 560 & H.R. 1409). The LP also commended many of the Branch Presidents, Chief Stewards, and members who attended public hearings protesting the Postal Services' proposal to consolidate outgoing mail operations, which could have serious impact on mail delivery.

# **VICE PRESIDENT'S REPORT (BLUM)**

The VP report began with an update on the RI-399 Committee. The Committee is presently reviewing cases involving procedural arguments, West Jersey's SPBS operation, and cases formally appealed to arbitration. The VP report also included our involvement in this

years' Labor Day Parade, which is tentatively scheduled for Saturday, September 12, 2009. Information will disseminate upon its formulation. Further into the report the VP discussed membership premiums. The availability of items will vary as usual; t-shirt will be black in color, with white lettering, large logo in front, lettering of NY, NJ, CT added. The EB will be electronically polled after the VP researches with vendor. The VP concluded his report with an update on the recent Legislative Conference. Executive Board members, Tabarus, Ruther, Hogrogian and the VP attended the Conference in May of this year. Blum submitted that the Local has always been politically active on behalf of the Mail Handlers; and that we have strong Congressional support. In conclusion of his report the VP discussed the importance of contributing to the Political Action Committee Fund (PAC). Participation in the Political Action Committee results in positive congressional support.

# **RECORDING SECRETARY'S REPORT (YANCEY)**

The EB discussed the matter of charges brought against an officer from Newark". The matter was tabled in order for the EB to process additional, related charges. Yancey's report included a discussion on the "Impact Questionnaire" offered at the LUC meeting to the Branch Presidents. Due to the Postal Services' consolidation and compression plans, the Women's Committee offered the questionnaire as a "voluntary" opportunity to have the members identify how these changes have impacted their lives; as well as lending a point of reference or "snapshot" of the impacted member to the losing or gaining facility. The RS also discussed the latest issue of the Caucus newsletter and in conclusion, discussed plans for the RYE Playland Family activity. A Core Team has been established.

Motion by: Yancey, 2<sup>nd</sup> by Blum: Local 300 will subsidize a social and recreational activity to Rye Playland. Members and guests will be charged \$25 for ride and BBQ or \$10 for BBO only. ### **NJ STATE REPORT (PRICE)**

The NJ report included an update on the RI-399's. All RI-399 grievances previously filed have been appealed to Step 3, except one Jersey City grievance. Management has throughout these proceedings; have delayed scheduling at Step 2 and have delayed in rendering decisions. Price is working aggressively to reverse the inconvenience that management has placed upon the grievance process. Price also reported; an increase in disciplinary action in the Associated Offices.

In discussing the Open Season, Price submits that due to the economic crisis, employees spent more time comparing health plans. The MHBP faired well with members in cost for coverage. Final numbers were positive for the Local showing a slight increase. Price reported that there were a few calls to his office from members regarding medical and dental bills. These problems were resolved through the Chicago office of the Plan. It is our hope to see an increase in the MHBP every open season.

# **CT STATE REPORT (RUTHER)**

Ruther offered a report on the Legislative Conference. Tom met with (D) Senator Chris Dodd regarding FMLA changes and pre-taxed health benefits. The Senator also talked of looking into repealing acts issues by the former Bush Administration. Ruther's report continues with a review of OWCP cases; and discussed a significant initiative by postal management against individuals who have been out for one-year of more. In closing, Ruther will be meeting with METS officials to discuss our outing for the game.
